1976

- Industry Canada issues Letters Patent on February 10, 1976
- First official meeting of the Board of Governors held on June 2, 1976 in Hamilton, Ontario
- First CRSP designation issued to William O.G. Wellington (76-001CM), Mr. Wellington was also the first Chair of the Association for Canadian Registered Safety Professionals' (ACRSP) Board of Governors

1979

• Fletcher Wright Associates Inc appointed management company

1980

- Work initiated on developing a syllabus outlining the scope and depth of examination subject areas
- Regional Screening Centres established

1982

- Mandatory examination introduced
- Committee established to develop Guidelines for Eligibility to Write CRSP Qualifying Examination

1986

• CRSP logo registered with Consumer and Corporate Affairs Canada as a registered trade mark on January 24, 1986
